Allegheny Synod – ELCA Synod Council Meeting January 21, 2023

The January Synod Council meeting was called to order by Bishop Paula at 9:00am

Upon motion by Bishop Paula, seconded by Vicar Allen Stump

• *SC23.01.01* - to adopt the agenda for today's meeting as amended... the motion is adopted

Upon motion by Pr. Becky Horn, seconded by Pr. Amanda McCaffrey

• *SC23.01.02* – to adopt the minutes of the November 19th Synod Council meeting & the December 6th Executive Committee meeting (*via email*)... the motion is adopted

Report of the Treasurer – Bill Layton

Summary position of revenues - thru Nov (10 months into the 2022-23 fiscal year)

- Total revenues of \$594,000
- Total expenses of \$667,000
- Surplus of \$29,000 for 10 months

• November results indicated a loss for the month (due to a quarterly partner payment) Detail of the summary

- Mission Support is down \$15,000 (roughly a 2% decline)
- There was a \$159,000 unrealized loss in the investment portfolio valuation
 - We regained \$56,000 in November alone in portfolio valuation

Moving forward

- The Mission support is also down
 - \circ $\,$ We are down to 45% of revenue forwarded to the ELCA $\,$
 - o Travel expenses are also down ytd
- ELCA Foundation was not asking Synods to participate during the pandemic
 - However, we opted to make a quarterly payment of \$1,250, which is our membership in the ELCCA Foundation
- Synod events net costs
 - Synod assembly \$3,500
 - Bishop convo \$3,700
 - Youth events \$226
- Balance Sheet
 - Cash position \$127,000
 - Investment portfolio \$2.6 million
- There was no spike in revenue this year reflective of the end-of-the-year Christmas giving by the congregations.

Upon motion Bill Layton, second by Vicar Allen Stump

• *SC23.01.03* – Contingent on receiving the anticipated bump in giving (from our congregations) in January (the last month of the fiscal year), that we return to our traditional 50% level of giving to the ELCA for fiscal year 2022-23... the motion is adopted

• *SC23.01.04* - To table the discussion of *SC23.01.03* until we have a discussion on the shared DEM position... the motion to table motion *SC23.01.03* is adopted

Bishop Paula announced that Treasurer Bill Layton does not intend to seek a 2nd term as Synod Treasurer.

- In May of 2019, Bill was appointed by the Synod Council to a 4-year term to begin on August 1, 2019.
- Bill has offered to continue beyond the August 1,2023 end-of-term date, until a new Treasurer is on board.
- From the Synod Constitution +*S*8.*41.* The Treasurer may be elected by the Synod Assembly or may be appointed by the Synod Council. The treasurer shall be a voting member of a congregation of this synod. The treasurer may be either a layperson or a rostered minister.
