

## Allegheny Synod – ELCA Council Meeting September 10, 2022

MISSION: Called by God to be one in Christ: we worship, grow in faith, and serve all people.

- 1. The September Synod Council meeting was called to order by Ann Ferry at 9:05 am
- 2. Presentation and adoption of the agenda
  - 1. Upon motion by Pr. Ralph Hamer, second by Bill Layton
    - a) SC22.09.01 to adopt the agenda for today's meeting...the motion is adopted
- 3. Approve or amend minutes of July 2022 meeting
  - 1. Upon motion by Bishop Paula Schmidt second by Michele Peese
    - a) SC22.09.02 to adopt SC22.07. minutes as presented...the motion is adopted
- 4. Bishop Paula Schmidt led us in devotions from a book *Making Room for God* 
  - 1. What do you feel called to give up to make room for God, for a time or a season?

- 6. Discussion Points
  - a) Disaffiliation Processes
    - 1. Upon motion by Bishop Paula Schmidt, second by Gary Gable
      - a) SC22.09.03 the Allegheny Synod Council affirms both Central Bedford Parish (7-0, 6-0, and 6-0) and Mt. Zion, Bakersville's (16-1) first votes for disaffiliation process as submitted through letters to the Allegheny Synod office...the motion is adopted
    - 2. Christ, Dubois will take their first vote to disaffiliate on September 18. The consultation is September 14.
    - 3. Grace Lutheran, Stoystown completing their transfer.
    - 4. Trinity, Johnstown's second vote to disaffiliate is scheduled for late October
  - b) Welcome in the church
    - 1. How do we show welcome, how can council members show welcome throughout the synod, what can we do to support congregations and people?
    - 2. The feeling of acceptance, at congregation and the community
  - c) Constitutional Update
    - 1. The model constitutions for Synods and Congregations have been distributed from the ELCA Secretary
      - a) Secretary David Finney can look at the new model constitution compared to congregation's current constitution

Synod Assembly Committee meets on September 15 to begin planning for 2023. The Blair County Convention Center has been secured for June 17, 2023.
